Personhood USA is hosting a national tele-town hall meeting with the Republican presidential candidates this Tuesday evening.

Individuals are encouraged by Personhood USA to [sign up on their](#) website to participate in the forum. The town hall conference will be held from 7 – 8:30 p.m. Mountain Time this Tuesday, Dec. 27.

Personhood USA serves the pro-life community by helping initiate legislation and initiatives to grant personhood rights for all innocent humans. The group is currently involved in helping get a personhood amendment on the ballot for next year's election.

Voters have twice before defeated personhood initiatives in the state, but the support for the issue has increased each time it has come before the voters. The new initiative is written in plain language and answers many of the criticisms of the previous proposals.

All presidential candidates have been invited to participate and at this time Newt Gingrich, Michele Bachmann, Rick Perry and Rick Santorum are confirmed.

Callers will have the opportunity to ask the candidates questions and give instant feedback to thoughts and ideas shared. The program will also be heard live on Steve Deace's nationally-syndicated radio show on the Salem Network.

The pro-life movement is under increased assault by the Obama justice department. Recently a pro-life protestor in Denver was charged with obstruction for talking to people outside of an abortion clinic.

The Justice Department has assigned five prosecutors to go after Kenneth Scott. According to the Attorney General's office, Scott was "obstructing" traffic because cars that stopped to talk to and receive literature from Scott of their own free will were preventing other traffic that may have wanted to pass.

In Oakland, California, the city has used selective enforcement of a law that created an eight foot bubble around any woman within 100 feet of a healthcare facility. While police have used it to arrest Pastor Walter Hoye, clinic "escorts" and others who came within the bubble are not similarly charged, despite the plain language of the law saying it applied to "anyone who is not a doctor, nurse or other employee of a health care facility."

Nurses at a hospital in New Jersey were also told they would be forced to perform abortions, regardless of whether they were opposed to the procedures or face termination. The case has since been resolved.
