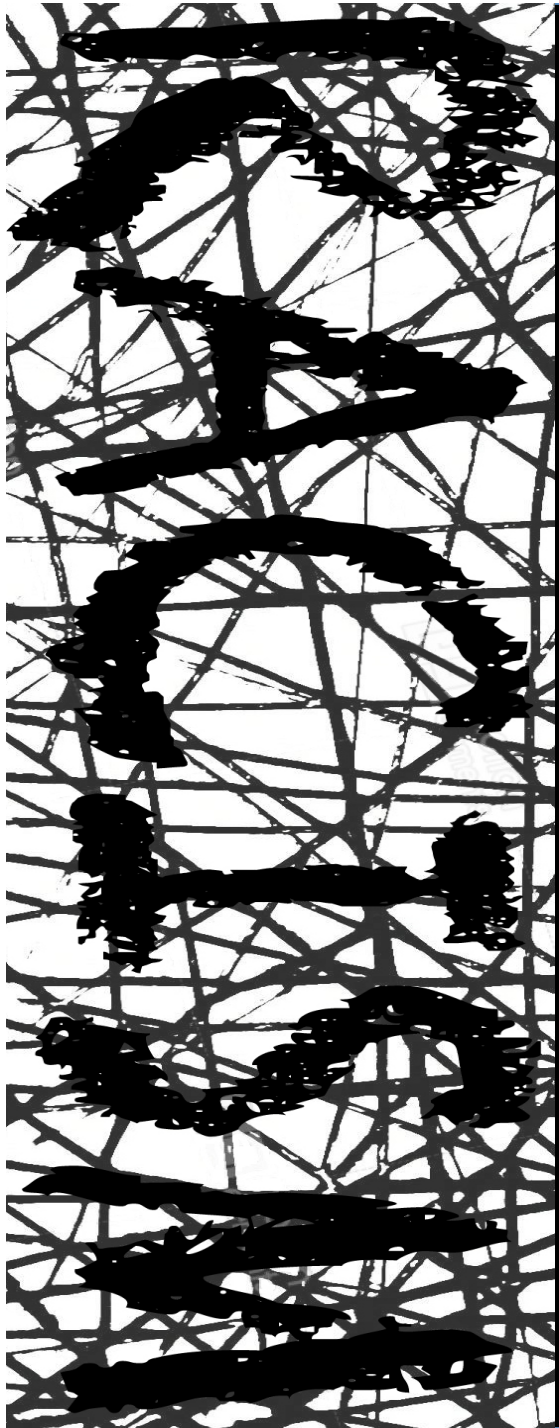

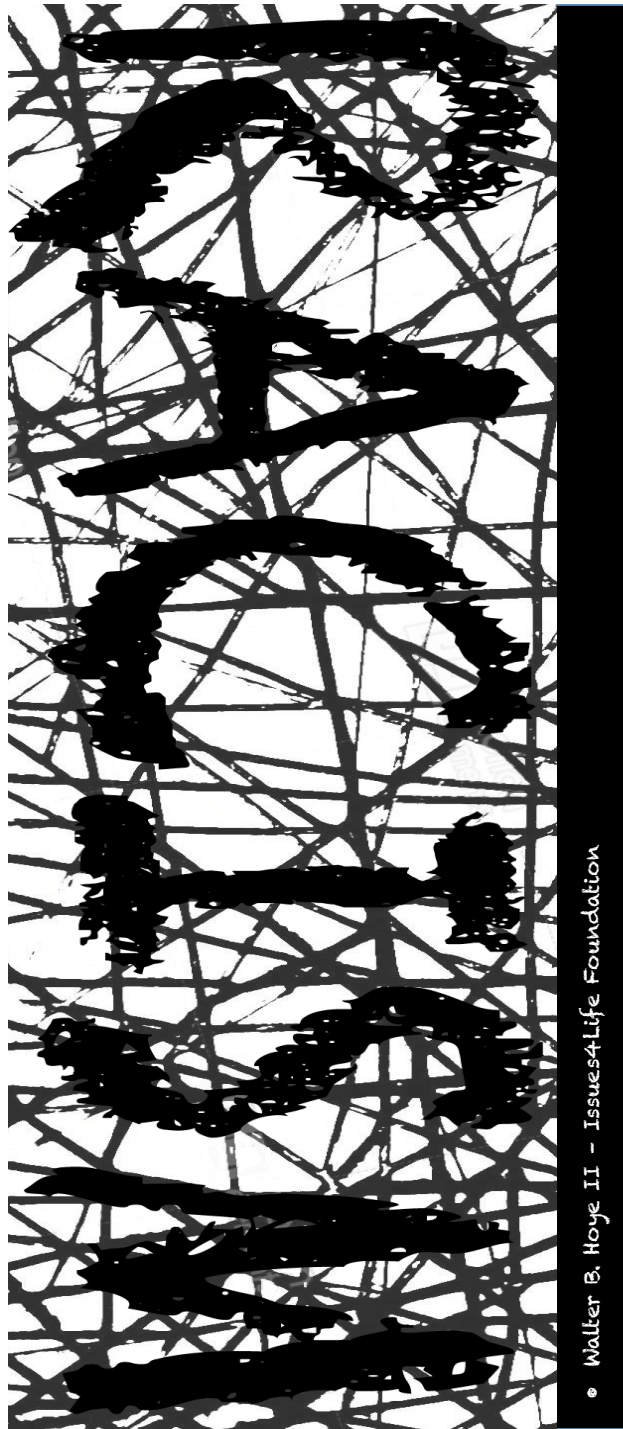
MARGARET SANGER

In 1921, Margaret Sanger founded the **American Birth Control League**, which later became the **Planned Parenthood Federation of America**. In the same year, Sanger also organized a **Birth Control Clinic** in Harlem (a predominately **Black-American** neighborhood), with an all **Black-American** advisory council, where **Black-American** staff were later added.

NEGRO PROJECT

"It seems to me from my experience ... that while the **colored Negroes** have great respect for **White doctors** they can get closer to their own members and more or less lay their cards on the table which means **their ignorance, superstitions and doubts**. We should hire three (3) or four (4) **colored ministers**, preferably with **social-service backgrounds**, and with **engaging personalities**. The most successful **educational approach** to the **Negro** is through a **religious appeal**. We don't want the word to go out that we want to exterminate the **Negro population**, and **the minister is the man** who can straighten out that idea if it ever occurs to any of their **more rebellious members**." ③

BIRTH CONTROL

For Margaret Sanger, the founder of Planned Parenthood, noted that the chief aim of birth control is to eliminate the reproduction of human beings who were considered "less fit."

"Knowledge of Birth Control is essentially moral. Its general, though prudent, practice must lead to a higher individuality and ultimately to a cleaner race. Birth Control is nothing more or less than the facilitation of the process of weeding out the unfit, of preventing the birth of defectives or of those who will become defective." (5)

KU KLUX KLAN

In 1926, Sanger spoke at a **Ku Klux Klan** rally in Silver Lake, New Jersey. Sanger describes her elation after receiving multiple speaking requests from **White Supremacy** groups.

"I accepted an invitation to talk to the women's branch of the **Ku Klux Klan** ... In the end, through simple illustrations I believed **I had accomplished my purpose**. A **dozen invitations** to speak to similar groups were proffered." ⑥

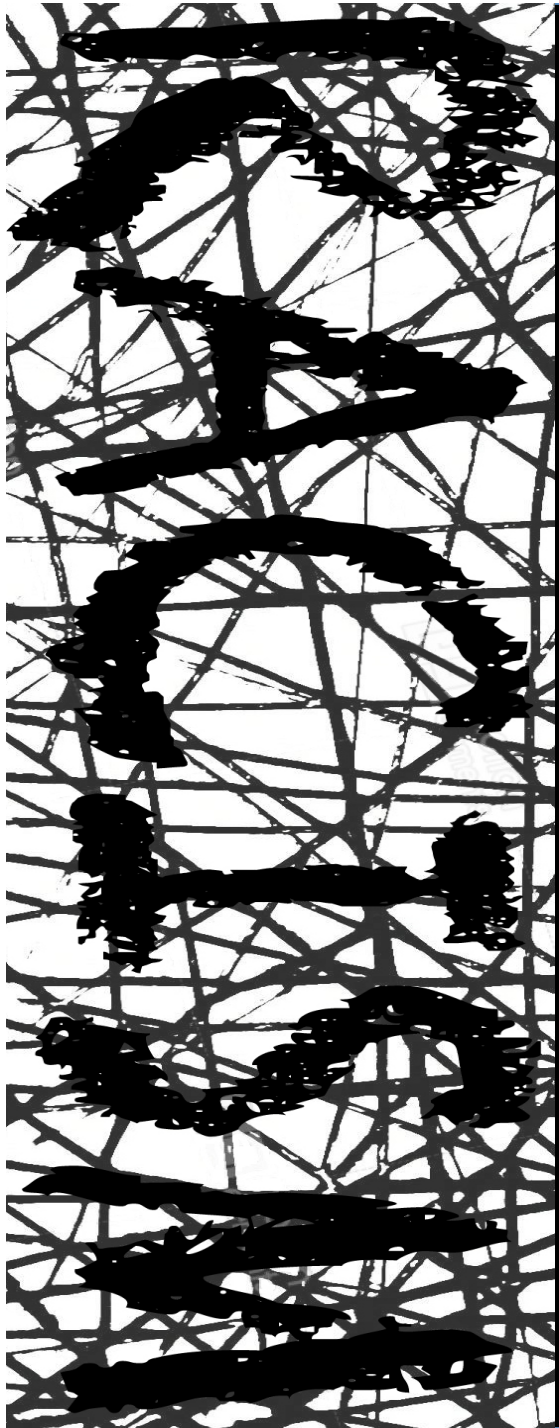

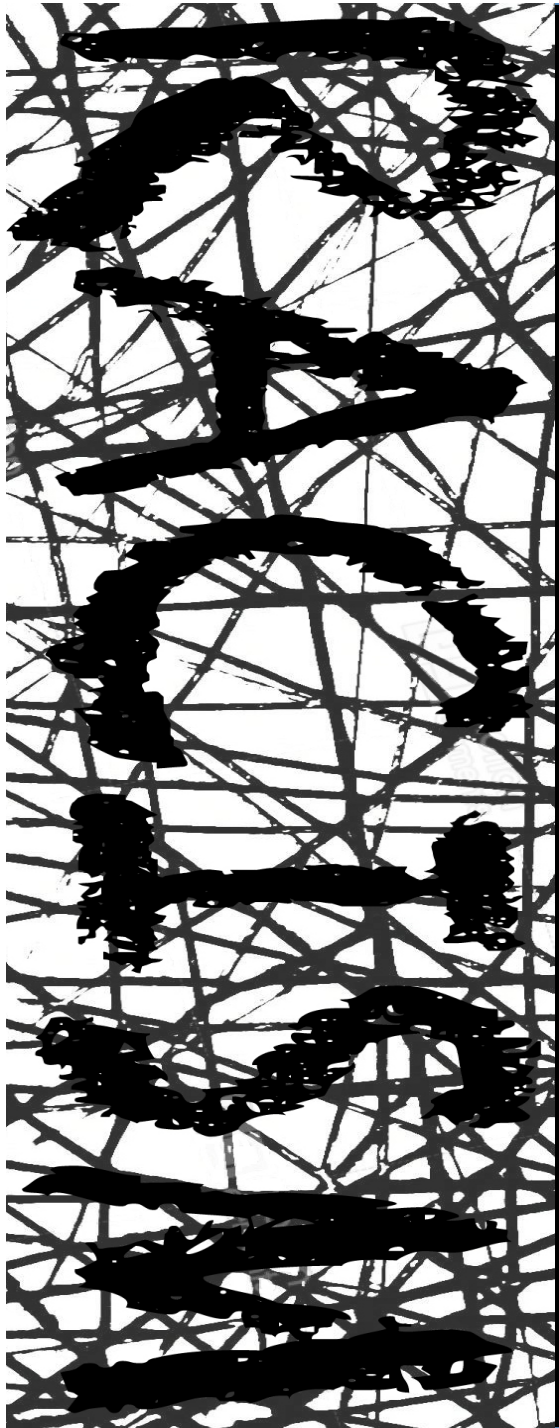
"Plan For Peace"

Birth Control Review (April 1932, pp. 107-108)

Article 1. The purpose of the **American Baby Code** shall be to provide for a better distribution of babies ... and to **protect society** against the propagation and increase of the **unfit**.

Article 4. **No Woman** shall have the legal right to bear a child, and **No Man** shall have the right to become a father, without a permit...

Article 6. No **permit for parenthood** shall be valid for more than one birth.

ON ADULTERY

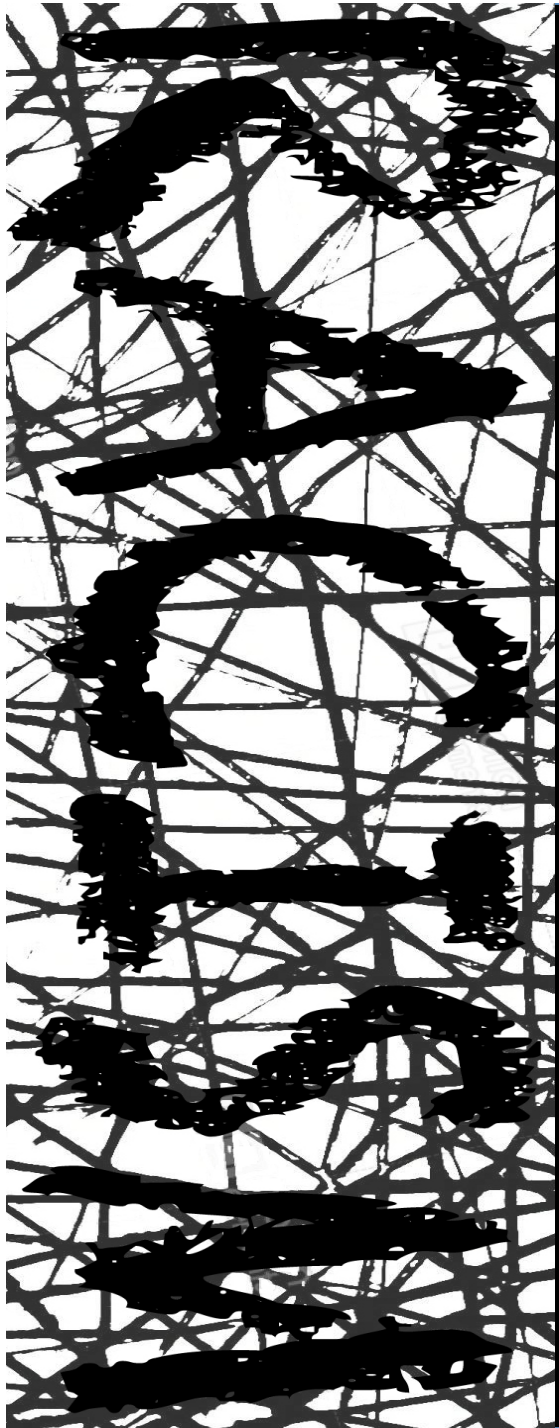
"A woman's physical satisfaction was more important than any marriage vow, Sanger believed." *Birth Control in America*, p. 11

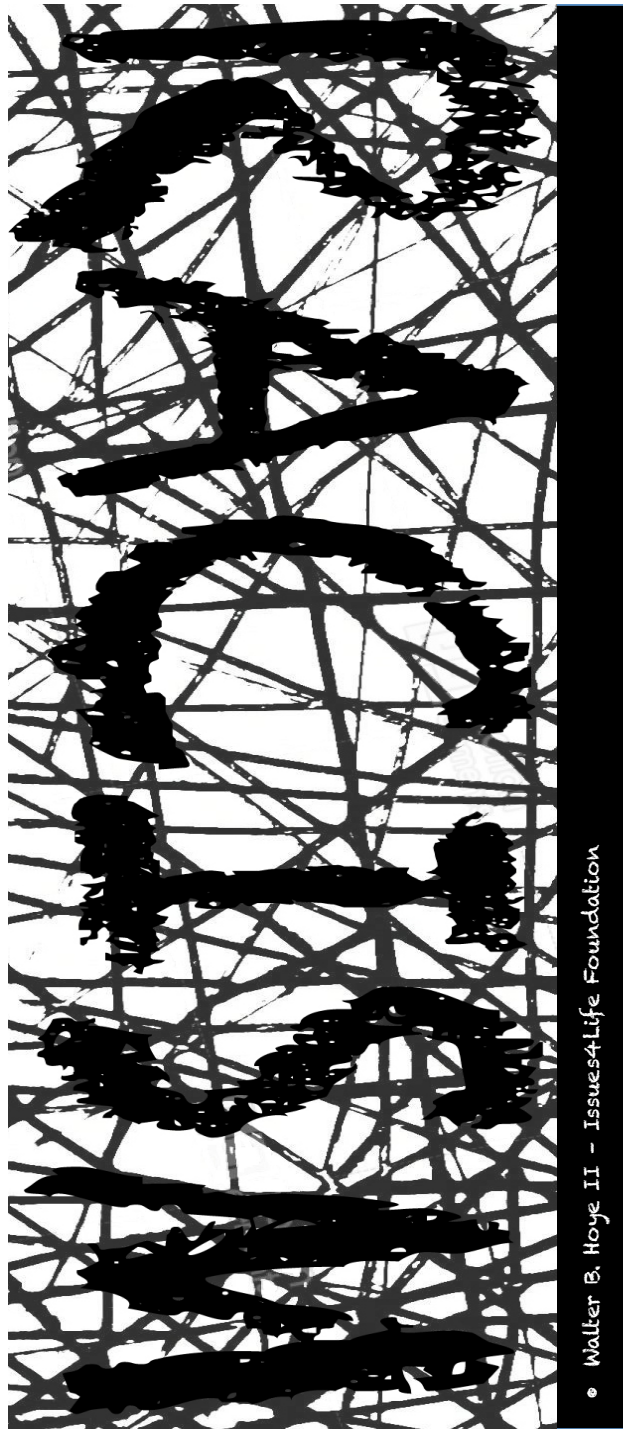

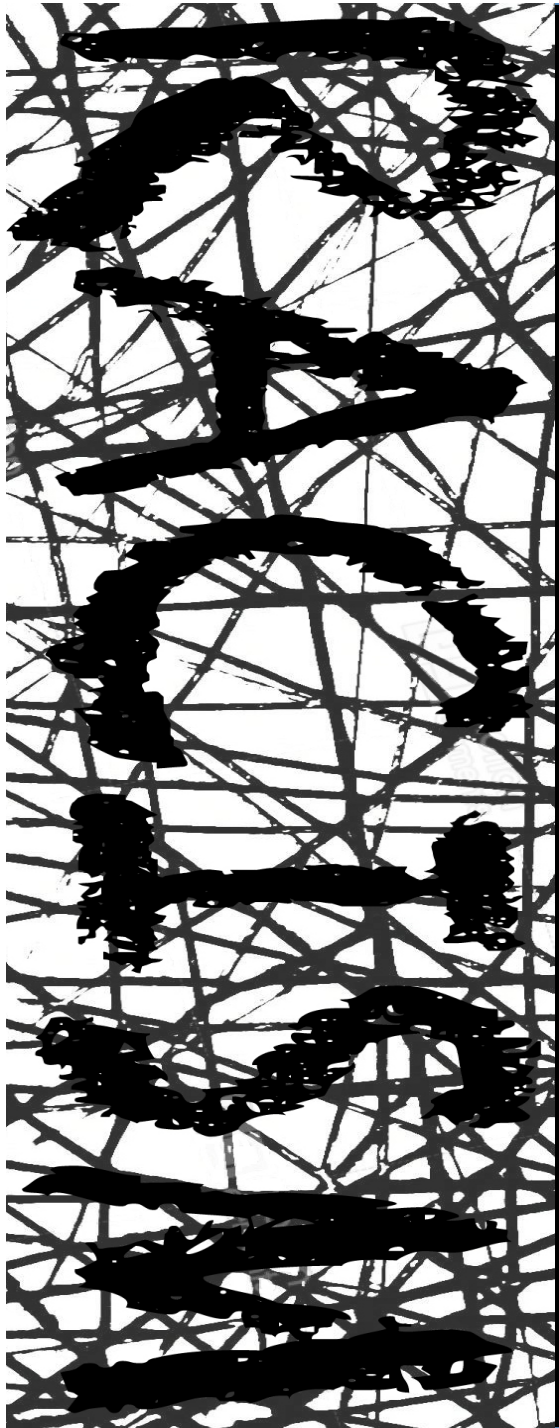

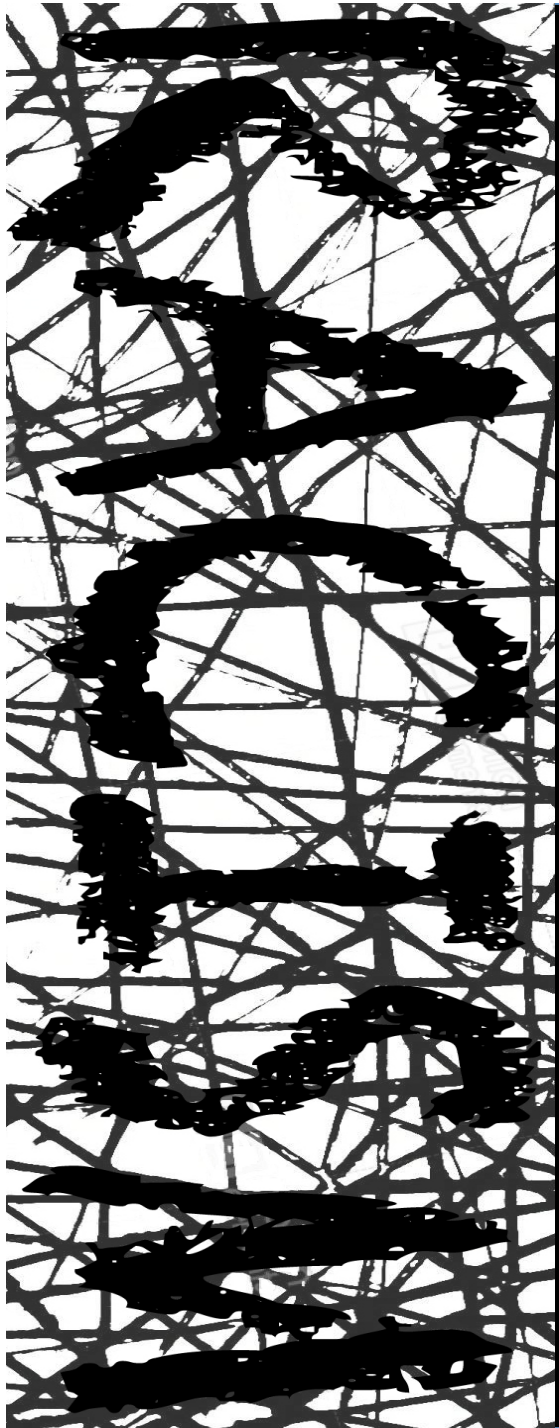
The two (2) original Pro-Life groups in America were Black organizations.

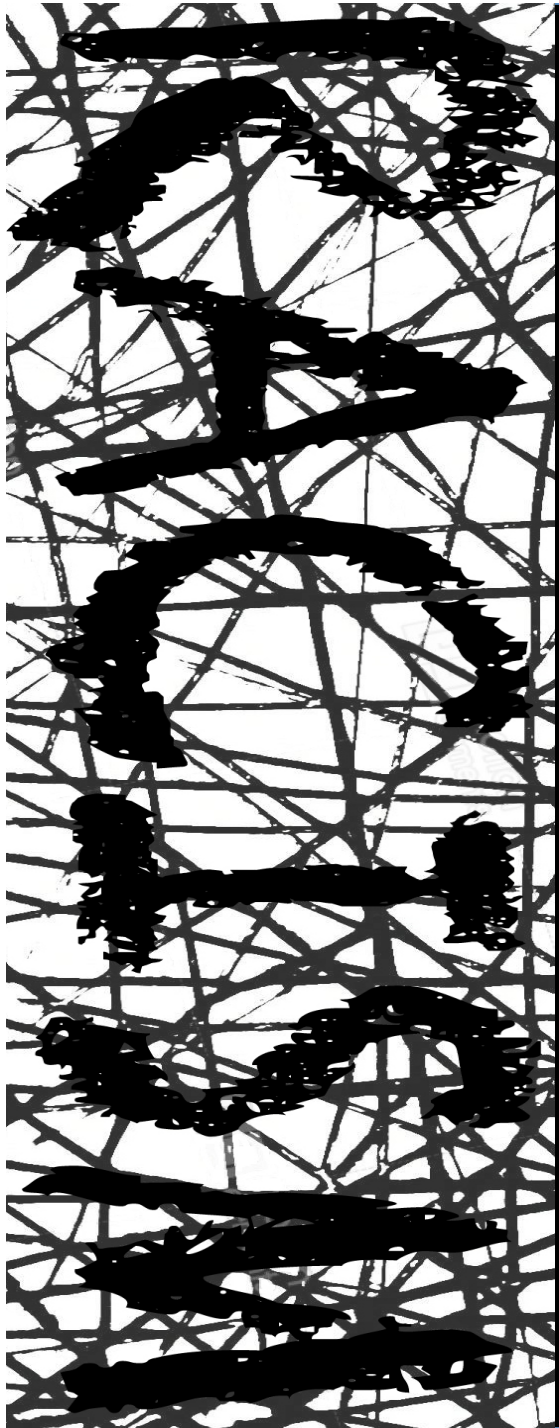
They were the Black Panthers and the Black Muslims.

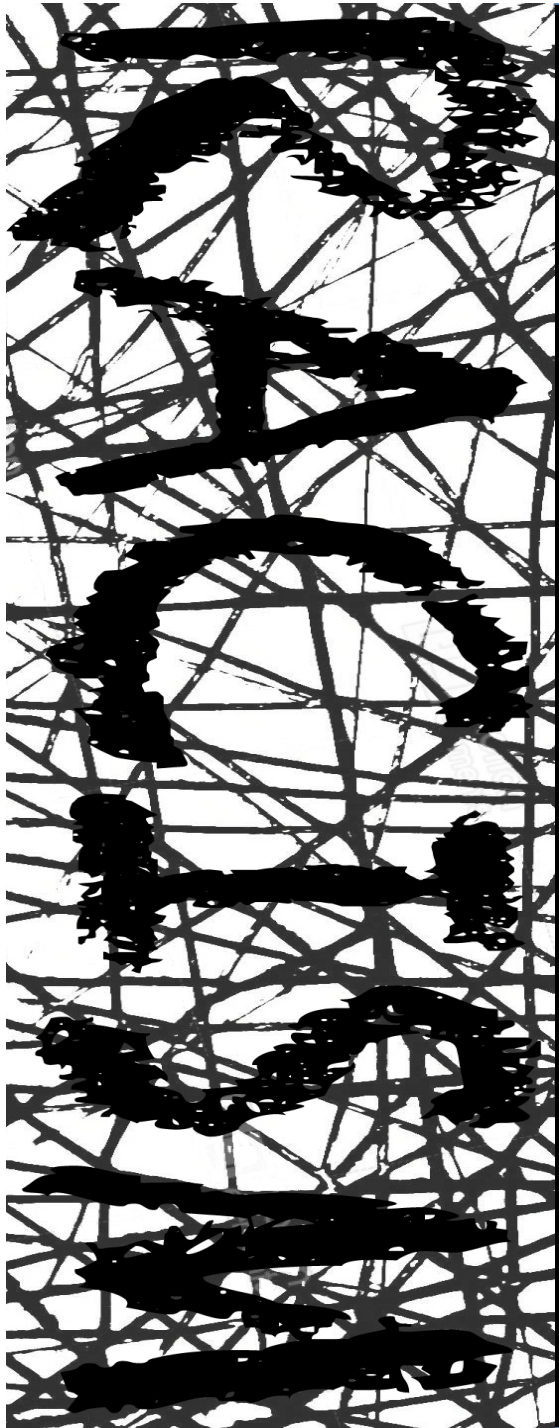


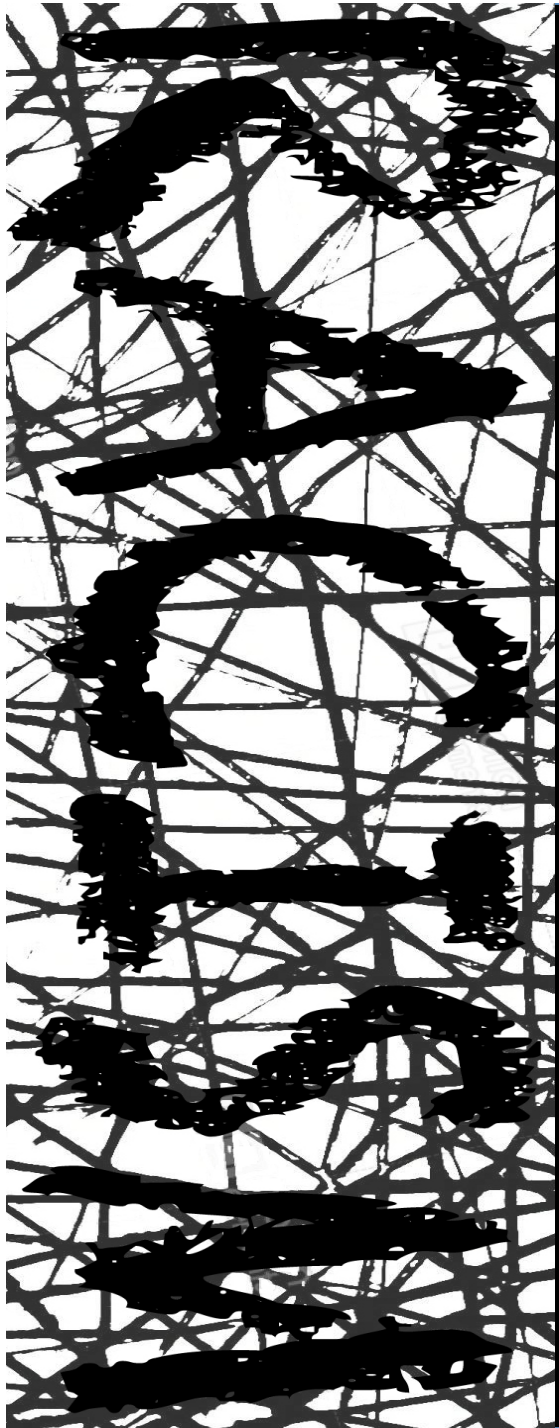
"At a meeting of the Council of Philadelphia Anti-Poverty Action Committee in 1965, **Cecil Moore**, president of the local NAACP chapter, condemned a **Planned Parenthood** program for northern Philadelphia because 70 percent of the population was Black. Labeling the plan 'replete with everything to help the Negroes commit race suicide.'"

DURING THE 1960s



"Muslim leader **Elijah Muhammad** warned against the 'disgraceful birth control laws now aimed exclusively at poor, helpless Black peoples who have no one to rely on.' He postulated that the White motive was **not to improve** the situation of Black families **but to eliminate future generations.**"





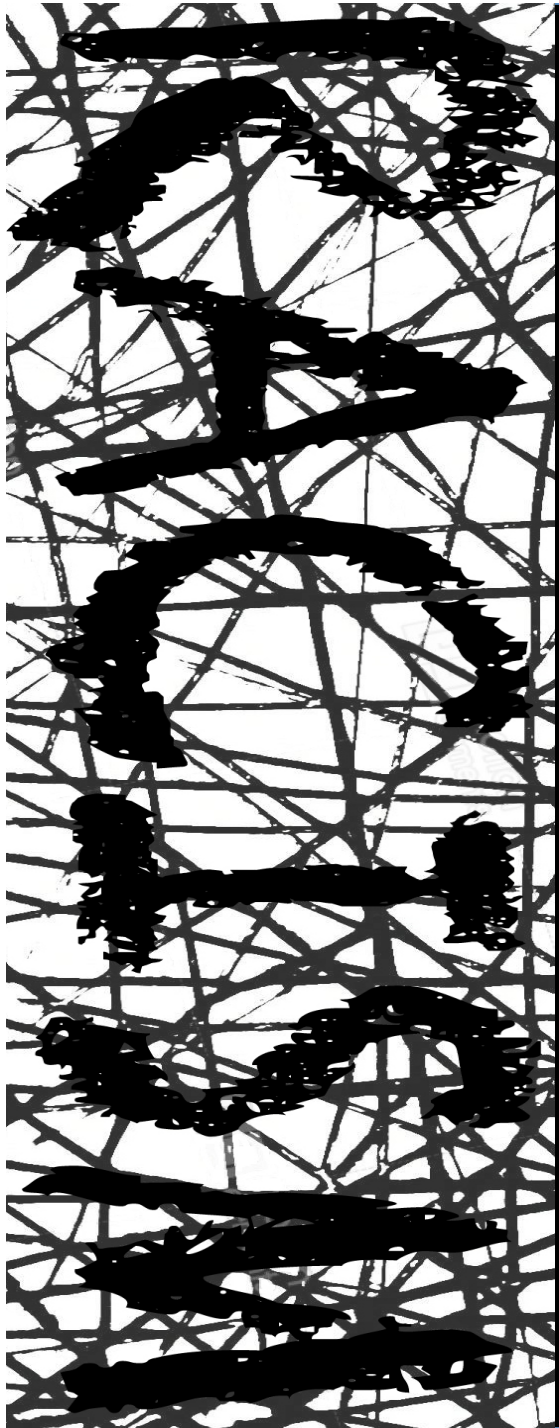

DURING THE 1960s

"**Malcolm X** also suspected genocidal motives behind population-control advocacy. 'It's easy to see the fear in their mind (**White America**),' **Malcolm** declared, 'that the masses of dark people ... will continue to increase and multiply and grow until they eventually overrun [other peoples] like



a **human sea**,
a **human tide**,
a **human flood**.'"

TODAY SANGER IS A NATIONAL TREASURE



Margaret Sanger's bust currently sits in the same exhibit that honors civil rights champions such as **Martin Luther King Jr.** and **Rosa Parks**. It's actually included in the gallery's "**Struggle for Justice**" exhibit. 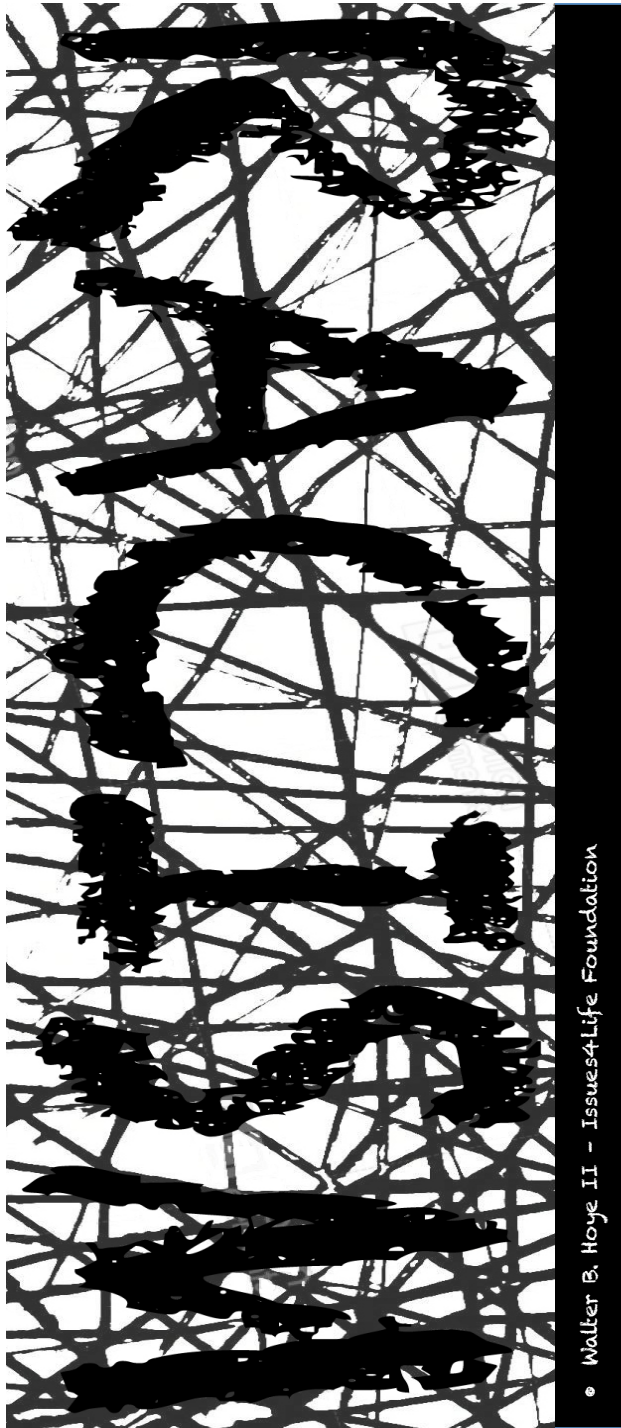

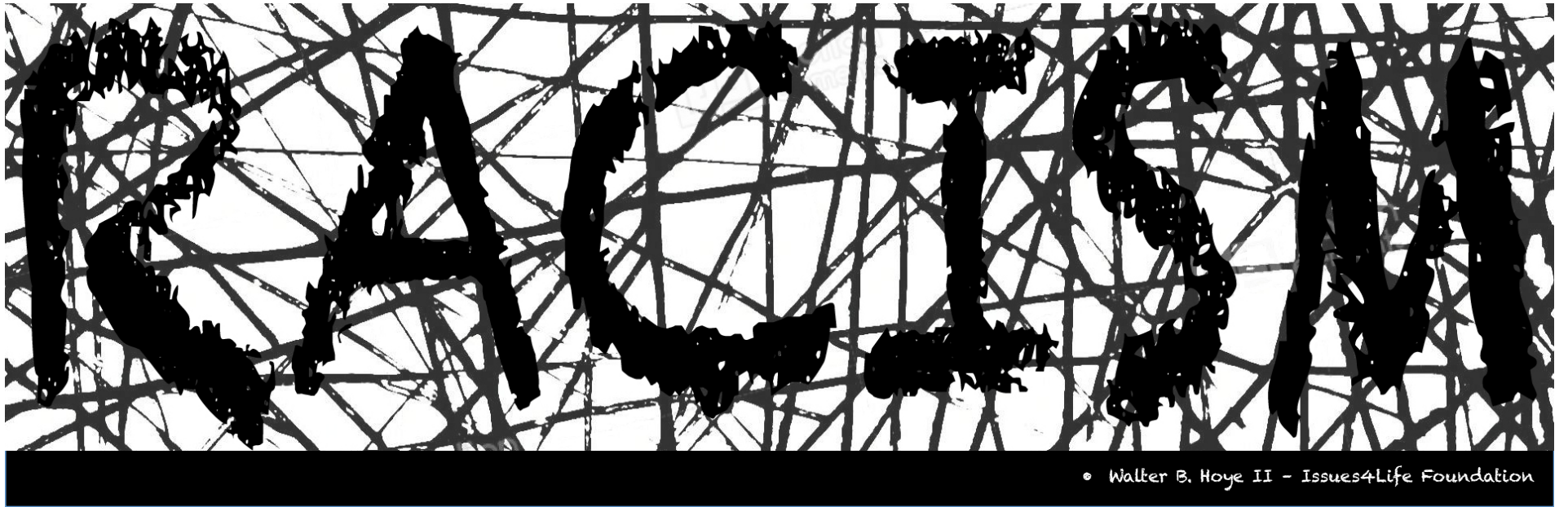
