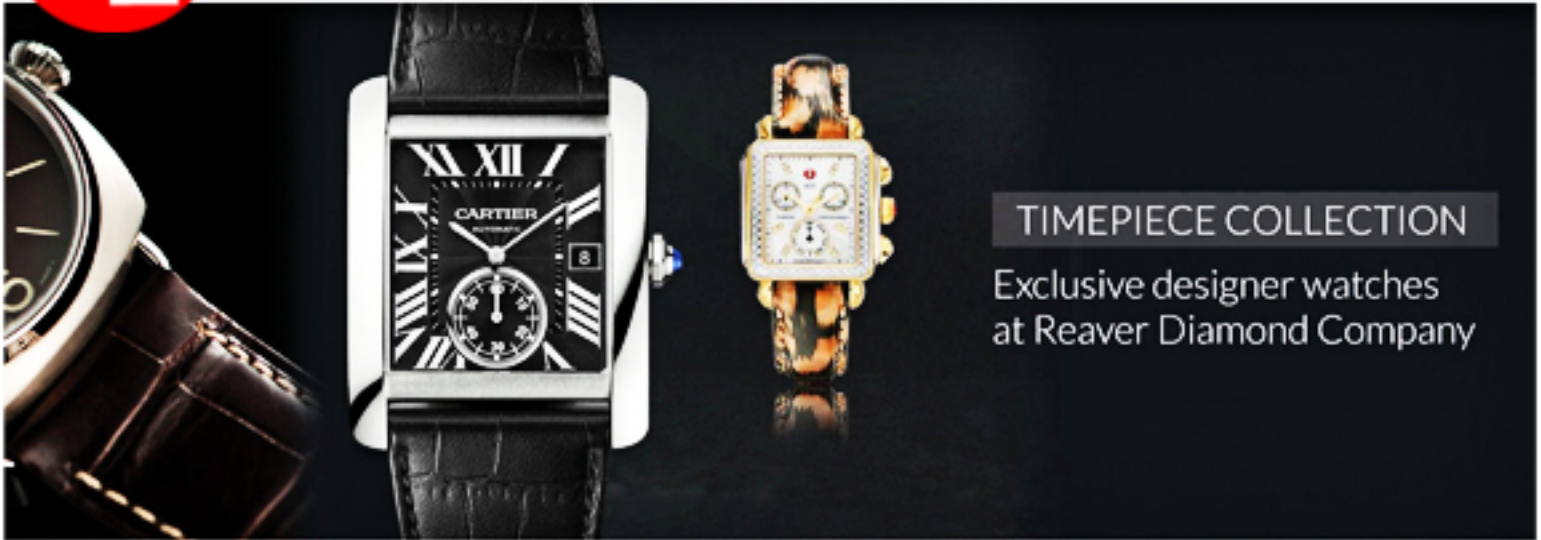

1. Start by contacting the **Reaver Diamond Company**. You can call [1-248-645-9200](tel:1-248-645-9200) or [1-248-DIA-MOND](tel:1-248-DIA-MOND) and ask for Steve, Chris, or Lara and discuss the jewelry you have in mind to donate to the **Issues4Life Foundation**. Or, if you prefer, you can email Steve Reaver at: Steve@ReaverDiamond.Com or his assistant Lara at: Assistant@ReaverDiamond.Com to start the process.
2. Once you agree to send the **Reaver Diamond Company** your jewelry, the **Reaver Diamond Company** will email you a simple disclosure document to verify ownership and that you are at least eighteen (18) years old and a bubble pack to enable you to mail your jewelry donated to the **Issues4Life Foundation** by USPS Priority Mail. If you follow basic shipping instructions, your donated jewelry will be fully insured through **Reaver's Insurance Block Policy**. It is highly recommended that donors photograph their items before mailing them for their records.



3. Once the **Reaver Diamond Company** receives your donated jewelry they will:

- (1) Photograph your donated jewelry
- (2) Analyze and appraise your donated jewelry and
- (3) Call you back with an exact quote regarding your donated jewelry.

4. At this point you will have **seven (7) days** to decide whether or not, to donate your jewelry to the **Issues4Life Foundation** or have your jewelry returned to you at your expense. After seven (7) days, your decision to donate your jewelry to the **Issues4Life Foundation** will be final.

5. Once your paperwork is executed, the **Issues4Life Foundation** will be notified of your donation amount. The **Issues4Life Foundation** will then send you a donation receipt upon receiving the donation amount from the **Reaver Diamond Company**.

What if the value of my jewelry is WAY less than I thought it would be?

You are under no obligation until you agree with the appraisal of your jewelry and have signed your acceptance to donate your jewelry to the **Issues4Life Foundation**. Your signed acceptance will authorize the **Reaver Diamond Company** to proceed with your donation.

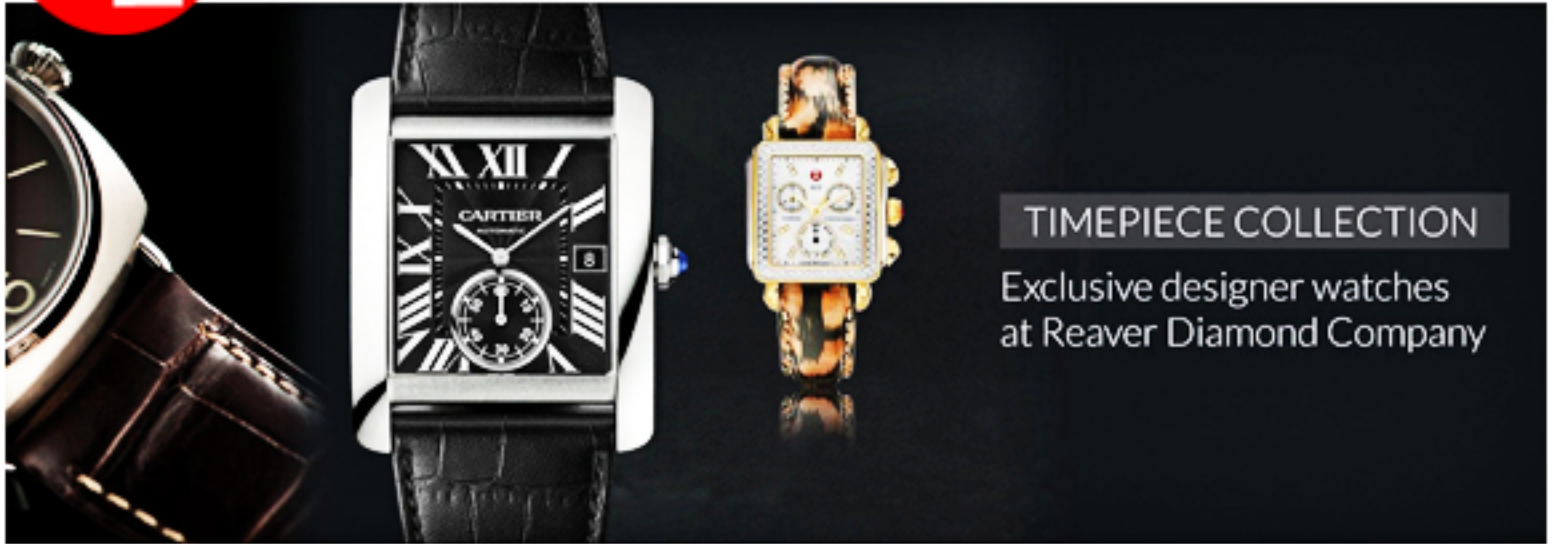
Is this basically like those commercials that ask me to mail in my jewelry but are really just scamming me?

What the heck does the 25% cover?

What is the minimum value amount that is considered?

At this time, the minimum jewelry donation should be \$500 or more.

How do I designate my gift?

Please designate your gift to the: **Issues4Life Foundation.**

I paid a retail amount for my jewelry, so how come my appraisal is so low?

These are a few reasons why the appraisal may be considered low:

Is your jewelry in fair or in excellent condition? The condition and quality of your jewelry will determine if your jewelry can be easily sold. **Is your jewelry still in demand?** If not, it may take much longer to sell and therefore could yield a lower appraisal value. **Was your jewelry purchased with a high retail markup?** If so, the appraisal could appear to be much less than you thought.
